BEACH RULES

- 1. DO NOT ENTER THE WATER IF YOU ARE EXPERIENCING OR RECOVERING FROM DIARRHEA OR HAVE HAD ANY SIGNS OR SYMPTOMS OF A STOMACH DISEASE IN THE PAST 7 DAYS
- 2. ALL CHILDREN WEARING DIAPERS MUST WEAR PLASTIC PANTS WITH SNUG FITTING ELASTIC WAIST AND LEG BANDS. THIS INCLUDES PULL-UPS. DO NOT WASH OUT SOILED DIAPERS IN THE BATHING WATER.
- 3. CHILDREN SHOULD BE ENCOURAGED TO USE THE RESTROOM BEFORE ENTERING THE WATER. IMMEDIATELY REPORT "ACCIDENTS" YOU OBSERVE IN THE BATHING WATERS TO A LIFEGUARD.
- 4. NO ANIMALS, EXCEPT FOR SERVICE ANIMALS SHALL BE ALLOWED IN THE BATHING AREA OR OTHER PARTS OF THE ENCLOSURE
- 5. GLASS CONTAINERS SHALL BE PROHIBITED IN FOOD AND DRINK AREAS
- 6. CONDUCT WHICH ENDANGERS THE SAFETY AND COMFORT OF OTHERS SHALL BE PROHIBITED
- 7. OUTDOOR BATHING SHALL BE PROHIBITED DURING AN ELECTRICAL STORM
- 8. PERSONS SUSPECTED OF BEING UNDER THE INFLUENCE OF DRUGS OR ALCOHOL SHALL BE PROHIBITED FROM ENTERING THE WATER
- 9. WATER TOYS AND FLOTATION DEVICES ARE TO BE USED AT THE DISCRETION OF THE LIFE GUARD IN ORDER TO ENSURE A SAFE BATHING AREA.
- 10. NO MOTORIZED VEHICLES, EXCEPT EMERGENCY AND MAINTENANCE VEHICLES SHALL BE PERMITTED IN THE BATHING AREA
- 11. NO BOATING, WATER SKIING, SAILBOATING, WINDSURFING, SCUBA DIVING, PADDLE BOARDING, SURF BOARDING OR FISHING SHALL BE PERMITTED IN THE SWIMMING AND BATHING AREA AT ALL TIMES
- 12. ROPE DROPS SHALL NOT BE PERMITTED EXCEPT THOSE LICENSED AND INSPECTED BY THE DEPARTMENT OF COMMUNITY AFFAIRS PURSUANT TO N.J.S.A 5:3-31
- 13. NO CHICKEN OR OTHER FORMS OF HORSEPLAY WILL BE PERMITTED BEACH FLAGS MUST FLY WHEN LIFEGUARDS ARE NOT PRESENT NO SWIMMING OR USE OF THE DIVING AREA AT ANY TIME WITHOUT A LIFEGUARD ON DUTY.

NO FISHING AT ANY TIME IN THE BATHING AREA OR DIVING AREA NO DOCK USE THAT IS ATTACHED TO THE DIVING AREA, IT IS UNSAFE AT THIS TIME.

NO DOGS OFF LEASH AT ALL FOR ANY REASON ON THE BEACH AND WATER AREA. DOGS MAY SWIM BY THE BOAT DOCK AREA ONLY!!
